### Obstacle Clinic Details:

- Riders are expected to have basic control of their horse, including the ability to walk, trot, turn, and stop their horse. Clinics may have up to 20 horses; riders should be comfortable riding in large groups and in pairs. Horses participating in the clinic should have some out-of-arena experience and be free of dangerous vices (i.e. kicking).
- Current Coggins and Rabies certificates are required. Please show papers to the Host Farm office prior to unloading.
- Boots and protective headgear are required. Balance of attire is discretionary.
- Food and drinks will be available to purchase.
- All entrants must sign liability and photo release forms. If under 18, a parent or guardian must sign.

### Cancellation Policy:

- If Gentle Dove Farm or Host Farm cancels the clinic, all payment received will be refunded within 30 days.
- Rider Cancellation: refunds will only be given for entry and stabling if entry can be filled from the wait list, less \$30 non-refundable office fee payable to Gentle Dove Farm. No changes or refunds after 9 am on April 15, 2010; wait list expires at that time.

**RELEASE AND HOLD HARMLESS/PHOTO AGREEMENT:** *The Undersigned assumes the unavoidable risks inherent in all horse-related activities, including but not limited to bodily injury and physical harm to horse, rider and spectator.*

The Undersigned agrees to hold Gentle Dove Farm harmless from any claim resulting from damage or injury while taking part in this Obstacle Clinic.
