OBSTACLE CLINIC DETAILS:

- **Riders are expected to have basic control of their horse, including the ability to walk, trot, turn, and stop their horse. Riders should be comfortable riding in large groups and in pairs on the trail. Horses participating in this clinic should have experience outside of the arena, away from home, and be free of dangerous vices (i.e. kicking).**
- Current Coggins and Rabies certificates are required. Please show papers to the Host Farm office prior to unloading.
- Boots and ASTM certified helmets are required. Balance of attire is discretionary.
- Food, drinks, and Gentle Dove Farm merchandise will be available for purchase.
- All entrants must sign the liability and photo release forms. If under 18, a parent or guardian must sign.

CANCELLATION POLICY:

- If Gentle Dove Farm or Host Farm cancels the clinic, all payment received will be refunded within 30 days.
- Rider cancellations: Refunds will only be given for entry and stabling if space can be filled from the wait list, less \$45 non-refundable office fee payable to Gentle Dove Farm. No refunds ten days or fewer before clinic. **Must be able available to participate either Aug 4th or Aug 5th, no refunds for moving the clinic to the rain date on Aug 5th.**
- Auditor cancellations: Pre-registered auditors will not receive refunds.

RELEASE AND HOLD HARMLESS/PHOTO AGREEMENT: The Undersigned assumes the unavoidable risks inherent in all horse-related activities, including but not limited to bodily injury and physical harm to horse, rider and spectator.

In consideration, therefore, for the privilege of riding and or working around horses at the Host Farm, the Undersigned does hereby agree to hold harmless and indemnify Gentle Dove Farm, Joann Long & all assistants. Further the Undersigned releases them from any liability or responsibility for accident, damage, injury, illness, or death to the Undersigned or to any horse owned by the Undersigned or to any family member or spectator accompanying the Undersigned on the premises. The Undersigned agrees to hold Gentle Dove Farm harmless from any claim resulting from damage or injury while taking part in this Obstacle Clinic. The Undersigned is responsible for any legal fees and/or expenses incurred by Gentle Dove Farm in defense of such claims.

In addition, the Undersigned also irrevocably grants full permission for Gentle Dove Farm or others affiliated with and authorized by Gentle Dove Farm to use and publish any photographs, videotapes, or electronic recordings taken of the Undersigned, even if such use and publication is for commercial or promotional purposes.
